In the original License Agreement, the City granted the Licensee a license pursuant to Section 3(B) of the ONG Franchise Ordinance to permit the Licensee to receive the 3rd Party Transport Gas at the locations listed on Exhibit A, pursuant to the Transportation Tariff Arrangement with ONG. In consideration of the license granted, the Licensee agreed to pay the Volumetric Rate fee specified in the ONG Franchise Ordinance to ONG, who will thereafter remit the fee collected to the City. Licensee agreed to pay the Volumetric Rate fee to ONG in a timely manner as part of the Licensee's regular monthly bills from ONG.

Licensee is requesting their original License Agreement be amended to include additional gas delivery locations listed below. The original License Agreement provides that the gas delivery locations may be amended by letter signed by an authorized officer of the Licensee and City Manager designee.
