Lock In Your Natural Gas Price

Energy prices can be as unpredictable as Oklahoma weather. But as an Oklahoma Natural Gas customer, you can know exactly how much you will pay for each Dekatherm of natural gas you consume over a 12-month period. Simply enroll in the Voluntary Fixed-Price Plan.

The price you pay for the natural gas you use each month is the Oklahoma Natural Gas average cost for the natural gas we've purchased for our customers under a variety of different contracts. The natural gas cost portion of your bill varies each month based on how much you use and what we paid for that supply.

We've already bought a portion of our winter natural gas supply at fixed prices so we know its cost. We're making that natural gas available to those who wish to enroll in the Voluntary Fixed-Price Plan at \$4.912 per Dekatherm for the 12-month period beginning November 1, 2013. The price only applies to the cost of the natural gas itself. Regular service and delivery charges apply, and your bill will still vary according to the amount of natural gas you use.



If you enroll in the Voluntary Fixed-Price Plan, you could pay more or less than customers who do not enroll in the plan. The plan does not guarantee savings; it is intended to protect customers from the wide swings in natural gas prices that sometimes occur.

Register your account online to make payments, view account history, manage billing options and more! Here's how:

1. Log on to www.oklahomanaturalgas.com.
2. Click the "Register Today!" button in the upper right corner.
3. Enter your information.

Voluntary Fixed-Price Plan Terms:

- Customers must enroll for the entire 12-month period and, once enrolled, will not be able to be removed from the program for the duration of the period.
- During the plan period, enrollees will pay a fixed price of \$4.912 per Dekatherm of natural gas used.
- If an enrollee moves within the Oklahoma Natural Gas service area during the plan period, enrollment transfers to the new service location.
- Customers may participate simultaneously in the Voluntary Fixed-Price Plan and the Average Payment Plan.
- Enrollees may not opt out of the Temperature Adjustment Clause.*
- Small commercial customers (businesses using 150 Dekatherms or less annually) must also enroll in the Automatic Bank Draft Plan in order to be eligible for the Voluntary Fixed-Price Plan.

* The Temperature Adjustment Clause is a means of adjusting a portion of your bill to reflect normal weather conditions from November through April each year. Customers have the choice to opt out of the program if they wish to do so.

Energy-Efficiency Program Announces Rebate Changes and Updates

The Oklahoma Natural Gas Energy-Efficiency Program recently announced changes to various rebate programs offering more money to customers. Approved by the Oklahoma Corporation Commission, the rebate changes are effective immediately and will run through 2016. The new rebates are as follows:

Furnace replacement program new efficiency levels:

\$150 Rebate: 92-94.9 percent efficient (formerly 92-95.9 percent)

\$550 Rebate: 95 percent efficient and above (formerly 96 percent)

Water heater replacement program new efficiency levels:

\$50 Rebate: Tank water heater with at least a 0.62 energy factor (formerly 0.67)

\$850 Rebate: Electric to natural gas conversion (no minimum efficiency requirement needed as compared to the previous requirement of at least 0.67 efficient)

Clothes dryer program new allocation for dryer/piping:

Rebate: Up to \$500 (\$400 for dryer and \$100 for installation/piping if performed by a licensed contractor; formerly \$300 for dryer and \$200 for installation/piping)

Two new programs will be added in 2014—a natural gas range program and a hydronic heating program.

All other Energy-Efficiency programs to remain the same.

Gameday Chorizo and Bean Dip

Ingredients:

½ lb. chorizo	2 tbsp. taco sauce
1 can black beans	¾ cup shredded cheddar cheese
½ cup chopped onion	2 ¼ oz. can chopped black olives
1 cup tomato sauce	¼ cup chopped scallions

Directions:

Preheat natural gas oven to 350 degrees. Brown chorizo over a medium natural gas flame, set aside. In saucepan, combine beans and onions; cover and cook over medium natural gas flame for 5 minutes. Mash beans slightly. Add chorizo, tomato sauce and taco sauce to saucepan; mix thoroughly. In separate bowl, combine cheese, black olives and scallions. Fold half of cheese mixture into bean mixture and pour into one-quart baking dish. Bake for 25 minutes at 350 degrees. Top with remaining cheese mixture. Serve with corn or tortilla chips. Serves 8-10 people.
