

**RATE SCHEDULE 235**  
**UNMETERED GAS LIGHT SERVICE**

**Availability**

Natural gas service under this rate schedule is available to any Customer on Company's system, or the system of another pipeline with respect to which the Company has an agreement with such pipeline for such service, but only to the extent that service to such Customer exists as of the effective date of this rate schedule, requiring natural gas service for gas lighting only, without the use of any metering device. Gas service is only available to Customers utilizing standard gas lighting equipment manufactured with a 71 drill size orifice burner assembly or equivalent. The Company, in its sole discretion, shall determine if Customer's lighting equipment qualifies for this tariff and shall contract with customer for the appropriate monthly charge based upon Customer's complete installation of gas lighting equipment. Company reserves the right to review Customer's installation of lighting equipment from time to time to determine if it conforms to industry safety standards and other terms and conditions as set forth in this tariff and the executed service agreement with the Customer. Customer shall notify Company in writing within 30 days of any change in number of gas lights or other material changes made to the gas lighting installation.

Gas service under this rate schedule is available only with the Company as the sole supplier of gas for Customer, and is not available for resale to others or for standby or supplemental service.

**Rate**

The charge per burner assembly in any month is as follows:

The monthly charge per burner assembly will be a flat rate of \$9.723 plus an additional amount based on the cost of gas. The amount associated with the cost of gas will be adjusted annually to the current per Dth Voluntary Fixed Price rate and will be effective with the November billing cycle.
